- Multi-Plastics Extrusions' products are not printed, painted or coated unless specified.
- Multi-Plastics Extrusions' products are not comprised of cellulose or other natural fiber.
- Multi-Plastics Extrusions does not utilize 2, 3, 7, 8-tetrachlorodibenzo (Para) dioxin in the manufacture of its products.
- Multi-Plastics Extrusions' products do not contain any natural rubber or dry natural rubber.
- Multi-Plastics Extrusions does not utilize any post consumer content in their products unless specified.
- Multi-Plastics Extrusions does not utilize Phthalates (DEHP, DINH, DOP etc.) during its production process nor are these chemicals expected to be present in any of our raw materials...
- Multi-Plastics Extrusions does not utilize Zonyl, fluorinated telomeric materials, or perfluorocarbon resins and/or solutions during the extrusion processes.
- Multi-Plastics Extrusions products do not contain: Nonyl-phenol Ethoxylate, Octyl-phenol Ethoxylate, Asbestos, Bisphenol- A, Organo-tins, Tris-Nonyl-phenol Phosphite, Methylnaphthalene, or Benzophenone.
- Multi-Plastics products are not intentionally formulated with any substances listed in the EU Directive 2009/48/EC (Toy Safety Directive), Annex II, Section III Chemical Properties. These substances include but are not limited to Arsenic, Antimony, Barium, Cadmium, and Selenium.
- The polyethylene terephthalate (PET), polystyrene (PS) and high impact polystyrene (HIPS) products supplied to you by Multi-Plastics Extrusions comply fully with the US Food and Drug Administration's regulations for food contact packaging. - Multi-Plastics Extrusions' products comply the US CONEG legislation, as well as the European Union Packaging Waste Directive. These products do not contain any lead, hexavalent chromium, cadmium or mercury; and if these material are present unintentionally/incidentally, they are present at trace levels below a sum concentration of 100 parts per million.
- Multi-Plastics Extrusions' products do not contain any listed Proposition 65-listed chemicals at levels requiring a warning statement. However, trace levels of ethybenzene are present in all polystyrene products but also not at a level that would require a warning statement on articles sold to consumers under California law.
- To the best of our knowledge, Multi-Plastics Extrusions' products are produced without the use of animal derived materials or animal by-products. We do have certification from the Orthodox Union that can be supplied upon request.
- Multi-Plastics Extrusions' products do not contain and are not manufactured with ozonedepleting chemicals listed under the Clean Air Act Amendments of 1990 nor require any warning related to such chemicals.
